Herewith is Report Form 11.B.

There are several points on which I need to draw your attention and I will take them in serriatum under their particular designation in the Certificate, viz:-

Ships Name It is now proposed to change the name from "DIGBY" to "DOMINICA"

Port of Registry By a advertisement in the "Liverpool Journal of Commerce" the ship is to be registered at Liverpool. From information I have received from the Repairers they state that the new Owners are:-

Bermuda & West India Steam Ship Co, Ltd,
Hamilton, Bermuda.

I think you might cross over and see the Owners and get the correct Port of Registry.

Under Deck Tonnage I have kept this Report back to obtain these figures. By Statutory requirements these figures are to be taken from the Ships Register. Up to date no Register has been issued. This hitch has arisen through vessel being measured in the Irish Free State. The Free State Government obviously cannot issue a British Board of Trade Register, Arrangements I understand are now being made whereby the British Board of Trade will accept the Free State measurements, and I also understand a Surveyor's declaration.
