I have surveyed the above ship in accordance with the Rules for damage stated sustained to the forward mast whilst loading at Port Said on the 21st July, 64.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

It was noted that the forward mast was buckled and bent to forward and starboard sides 10 degrees each way. Mast plating cracked and torn at one foot below the cross beam.

It was then recommended that the mast be released at the rivetted seam approximately 1'6" below the cross beam, removed, cropped, part renewed & refitted in place, and tested upon completion. T/A

The Master requested to defer permanent repairs until arrival to Piraeus where the vessel was proceeding direct. The top part of mast was then rigged by three wire ropes and was considered efficient meantime, subject to the derricks not being used meantime.

It is also recommended that the mast plating be specially examined for possible corrosion and be dealt with as found necessary.

I recommend that this ship remain as classed with/without fresh record of dry docking survey, subject to the forward mast being specially examined and dealt with as found necessary at Piraeus, where the vessel is proceeding direct, subject to any condition at present attached to the class being dealt with as previously recommended.

It is now recommended that the class be made subject to the forward mast be specially examined and repaired at Piraeus where the vessel is proceeding direct.
