



Dear Sir,

With reference to your letter of the 17th instant and to the memorandum attached to same having reference to the Loeffler boiler proposed to be fitted on the steamer "CONTE ROSSO" we are forwarding, herewith, for the consideration of the Committee, translation of letter dated 26th instant received in reply to same from the S. Andrea Engine Works of Messrs. Cantieri Riuniti dell'Adriatico, also a table showing the various factors used by the Witkowitz Works in the calculation of the tubes and headers shown in plans Nos. 2497, 2500, 2499 and 2504, which are enclosed herewith for farther consideration.

With regard to plan No. 2529, which was approved only as regards the tubes, we desire to draw attention to the statement contained in Messrs. Cantieri Riuniti's letter regarding the cylindrical shell, which is to be solid drawn, without longitudinal joint, and the internal pressure of which will not exceed 14 atmospheres.

We may farther add that a representative of Messrs. Witkowitz has been recently at Trieste and that the undersigned


