If the vessel, after planking, or if the vessel is of unusual thickness the breadth of vessel to inside the plating should be reported. The height of the R. Q. Dk. should be taken from the level of the top of the amidship beam. In vessels having a raised mean sheer means the sheer measured at the stem and stern. In vessels having a raised forecastle, it means the sheer measured at points distant from the stem and stern-post.

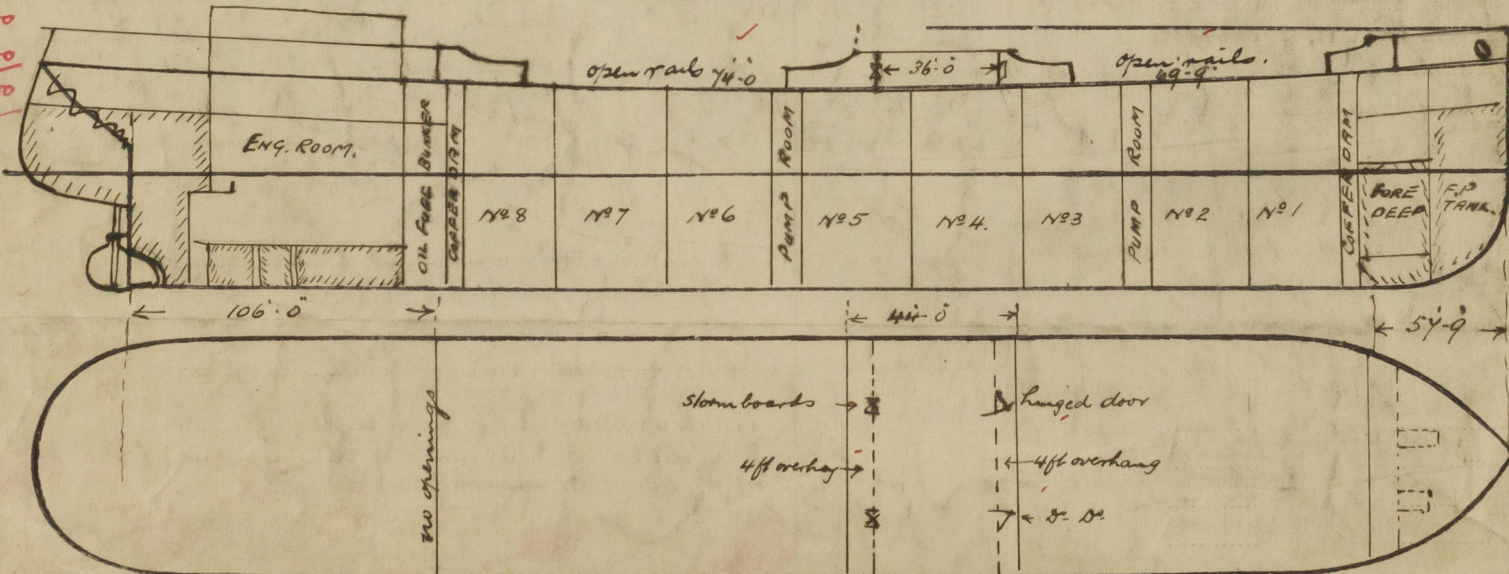
