Dear Sir,

In reply to your letter of the 7th. August, 1947, regarding the m.v. "ELISABETH" Rot.Report No. 99578, I beg to state that the water ballast tank as referred to has been examined internally and found in good condition. ✓

The tank, however, is not used as ballast tank and is only connected with a hand pump for draining. ✓

The capacity of same is 3 tons. ✓

The scantlings and spacing of the stiffeners of the after peak are correct; I may, however, observe that the flare of the shell at that part of the vessel is such that the length of stiffeners exceeds nowhere 2,00 mm. ✓

The spacing of 750mm in my report is the maximum spacing in the ships sides, the spacing of the stiffeners near the centre being 630 mm. ✓

The arrangement of pillars is as shown on the approved plans. ✓

The situation of the oil fuel tank is not in full confirmation with the approved plans, there being a clearance of about 200 mm. between the bottom of the tank and the top of the water ballast tank.

The tank is supported by beams and the sides are clear of the ships sides, reason why this tank has not been regarded as part of the ships structure. ✓
