6th December Left Larne in tow for Bowling.

9th December Owners state that bottom damage is extensive, and the ship will be broken up at Port Glasgow. (Glasgow letter 9.12.55.)

SOURCE OF INFORMATION

SAINT ENOCH. — Belfast, Nov. 23. — Steamer Saint Enoch reported ashore at Portmuck near Larne.

SAINT ENOCH. — Glasgow, Nov. 24. — Tug Flying Petrel last night left Greenock to go to the assistance of steamer Saint Enoch, aground on Magee Island. The crew of 11 was stated to be remaining on board. The Magee Island coastguard station, from which the grounded coaster could be seen, reported that the vessel was in no danger. She was expected to be towed off at high tide this morning. — "The Glasgow Herald." (See issue of Nov. 24.)

Belfast, Nov. 24. — An attempt by a tug to refloat steamer Saint Enoch failed. — LLOYD'S List Correspondent.

Bangor, Co. Down, Nov. 24. — Donaghadee lifeboat was launched at 1 30 p.m. to take off crew of steamer Saint Enoch, aground on Muck Island, Antrim Coast.

SAINT ENOCH. — Belfast, Nov. 24. — Steamer Saint Enoch stranded on shingle and boulders between Muck Island and mainland of County Antrim at 4 p.m. yesterday, while on voyage from Belfast to Bonawe, in ballast, one hour before high water. Owners have tug Flying Petrel attending. Attempt to tow vessel off ground in early hours of this morning failed. Attended vessel at low water at noon to-day and again near high water at 6 p.m. and regret to report refloating effort again failed. Tides improving and further attempt planned for to-morrow evening. Vessel making some water but controlled by ship's pumps. Making further examination to-morrow. Suspect centre keelson damaged at No. 2 hold, also bottom shell this vicinity. — Salvage Association's Surveyor. (See issue of Nov. 25.)

Bangor, Co. Down, Nov. 24. — Donaghadee lifeboat returned to station at 11 15 p.m. Five members of crew of steamer Saint Enoch landed at Larne. Master, mate, chief and second engineers remaining on board. Attempt to refloat Saint Enoch unsuccessful.

SAINT ENOCH. — Belfast, Nov. 25. — Steamer Saint Enoch: We telephoned owners this morning recommending their representative should attend without further delay, also that salvage pumps be placed on board and where possible leaks be made good before a further attempt by tug Flying Petrel to tow vessel off. Owners have since appointed surveyor Mellwaine on their behalf and have left sufficient crew on board. We have requested Mr. Lee, salvage contractor here, to contact owners and Mellwaine immediately, which they are doing. Flying Petrel is making a further attempt this evening on owners' instructions and if successful, intention is for vessel to proceed to Larne. (Later) Saint Enoch refloated at 6 40 p.m. to-day and proceeded to Larne harbour under own steam. She is now beached there. — Salvage Association's Surveyors. (See issue of Nov. 26.)

Belfast, Nov. 26. — Steamer Saint Enoch has now been beached at Larne Harbour; crew ordered back.

Belfast, Nov. 26. — Steamer Saint Enoch, ashore off Magee Island, was refloated by tug Flying Petrel last night and beached in Larne Harbour. Vessel's pumps able to deal with leak in No. 2 hold. Survey will be carried out on Tuesday (Nov. 29). — LLOYD'S List Correspondent. (d)

SAINT ENOCH. — Belfast, Dec. 5. — Steamer Saint Enoch left Larne at 9 a.m. to-day, in tow, for Bowling. — Salvage Association's Surveyor. (See issue of Nov. 28.)
