Panama, as the vessel lay afloat at the Banana Quay, Bremerhaven, for the purpose of examining and ascertaining the nature and extent of the damage sustained on September 17th, 1951, as a result of a collision with M.V."ESSO HULL", 10394 Tons Gross, of London, which occurred when the "ESSO HULL" was moving berth and SS "ANDREAS G" lay alongside the Quay.

Damage repairs commenced 18.9.52
" " completed 20.9.52

The damage was confined to the Port bow of SS "ANDREAS G".
The damage to M.V."HULL" is stated to be superficial.

On examination :-

FOUND:

On Port Side
Plate No.1 from fwd., shelter
deck sheer strake, sharply
indented at after end, area
about 15" diam.

Frame in way of above severely
buckled.

RECOMMENDED:

Crop and renew Plate No.1
5' x 4' x 375", butt electric
welded.

Crop and renew frame No.5 from
fwd. 3' x 7" x 3 1/2" x 375".

CONTINUED:

No.5 beam knee bracket
buckled

Nos 1 & 2 bulwark plates
slightly set in and rail
bar buckled.

Remove, fair and refit No.5
beam knee bracket.

Part release and fair in place
Nos.1 and 2 bulwark plates.
Crop and renew rail bar,
9' x 6" x 3" bulb angle.
D.G.Casing to remove for access
and refit.
One side-light to remove and refit
in new plate.
Equipment in forecastle to remove
for access and re-store.
Shell plating to hose-test in
way of repairs.
New and disturbed work to coat.

The above work has been completed satisfactorily by Messrs. Norddeutscher
Lloyd, Bremerhaven.

In the opinion of the undersigned, the damage is consistent with the cause
as stated.

The cost of repairs amounts to £ 408-9-0 which sum is considered fair
and reasonable for the work done and the material supplied.

This report is issued without prejudice to the Underwriters' liability
and costs are subject to adjustment.
