

# LLOYD'S REGISTER OF SHIPPING

the undersigned Surveyor to this Society did at the request of Messrs. Thomas L. Carr & Son, Lloyd's Agents on behalf of the Salvage Association and with the consent of the Owners, attend on board the

S.S. "CAMPANIA", 6,866 tons gross of Genoa.

whilst lying afloat at this port on the 18th January, 1960, for the purpose of ascertaining the nature and extent of damage stated to have been caused by being struck by the S.S. "TERESA VIGO" whilst moored at Molo Galliera on the morning of the 15th January 1960.

The vessel is at present laid up and no ship's log book is being kept on board.

The damage was to the port side of the bridge deck and bulwarks, in way and was considered to be consistent with and may reasonably be attributed to the alleged cause.

Upon examination the following damage was found and repairs recommended without prejudice to the terms and conditions of insurance.

FOUND

RECOMMENDED

Bridge deck curtain plate and deck stringer bar in way buckled.

Crop and renew 8'-0" x 13 3/4" x 3/8" curtain plate. Crop and renew 8'-0" of 3" x 3" x 3/8" stringer angle bar. Fair in place 6'-6" of curtain plate.

Bridge deck stringer plate set down.

Crop and renew 3'-0" x 15" x 1/4" of deck plating.

FOUND

RECOMMENDED

Deck beam end in way buckled.

Release and fair in place beam end.

Two awning stanchions with deck brackets in way bent and buckled.

Release, fair in workshop and refit 2 stanchions 7'-6" x 4" x 4" x 3/8" angle bar.

Bulwark plate in way of stanchions set in.

Release, fair in workshop and refit 4'-8" x 38" x 1/4" plate.

Bridge front bulwark broken at outboard corner,(wood).

Repair as necessary.

For access to the above repairs it is necessary to erect staging .

The foregoing recommendations were made with a view to place the hull in the same good and efficient condition as before the alleged casualty occurred.

No repairs have been carried out at this time.

Vessel is at present laid up.

Estimated cost of repairs: 270,000.- Lire  
Estimated time for repairs: 3 days.
