ion 1	To be of sufficient strength.	Scantling plans approved by Lloyd's London, per their letter of 14th October 1930.
e	Not less than 7% of length of ship and not less than standard height.	49'9" long x 8 ft high.
	<u>Openings on freeboard deck.</u> To have steel doors.	No openings on freeboard deck.
	<u>Bulkhead at end of poop.</u> To be same scantlings as bridge front and to have effective closing appliances. Sills to openings 18" deep.	This is all arranged.
	<u>Exposed casings on superstructure deck.</u> To be substantial construction and openings to be closed with steel doors capable of being closed from inside or outside. Sills 15" deep.	This is all arranged.
	<u>Fidley Openings.</u> To have strong steel covers permanently attached.	This is arranged.
vi	Efficiently constructed gangway.	Plan sent to Owners and returned approved. Lloyd's N.Y. letter of January 29th to the Pan American Petroleum & Transport Co asks for diagonal bracing at every 2nd span both transversely and fore & aft, and this is arranged.
