852 gross registered tons of Port Limon, whilst lying afloat at Alexandria, for the purpose of ascertaining the nature and extent of the damage stated to have been caused by Heavy Weather encountered on 22nd December, 1952 whilst on voyage from Port-Said to Alexandria.

On examination, it was,

FOUND

Main Engine.

Six (6) crankshaft main bearings, white metal cracked and loose in bottom halves and in one top half.

Thrust shaft.

Collar faces scored and rough. White metal on six (6) ahead and one astern shoes scored and worn.

Screwshaft.

Badly grooved approx. 6" from large end of taper on body of shaft in way of defective oil gland.

Stern tube bush.

Piece of flange broken off and tube cracked. White metal cracked and loose. Stern tube bush and white metal to renew complete.

RECOMMENDED


Six bottom halves and one top half to be remetalled.

Crankshaft to rebed, and alignment of shafting to be checked.

Thrust shaft collar faces to be skimmed. Six ahead and one astern shoes to be remetalled.

Screwshaft to be renewed.

RECOMMENDED.

Oil gland.

Securing tap bolts broken and part resting on screw-shaft. Faces badly scored.

All faces to skia gland to completely overhaul and tap bolts to renew.

M.E. attached pump lever arms slightly bent.

Pump lever arms to fair and re-align.

* Further recommended that all removals be replaced, and where damaged in the course of the above repairs, repaired or renewed as necessary.

These recommendations made so as to place the vessel in the same good and efficient condition as before the alleged damage was sustained.

The above repairs have now been completed to my satisfaction.
