We thank you for your letter of 15th instant, from which we observe it is desired to submit this case to the Committee with a view to a casualty record being inserted against the ship's name in the Society's Register Book. It is understood that should this record be made her class will be expunged at the same time.

In reply, we wish to state that we have no objection to this action but would mention that the vessel was lost on the night of 5th/6th November. As the Ministry of Transport are still considering the actual cause of her loss, we feel the words "by explosion" should be deleted meantime.
