the undersigned Surveyor to this Society did at the request of

Messrs Aitken Spence & Co.Ltd., (Lloyd's Agents at this port) on behalf of the Owners, Messrs Ambassador Steamships Private Ltd., and with the consent of the vessel's Master attend on board the s.s. "EFFIGYNY" 871 tons gross of Bombay whilst the vessel lay afloat at this port on the 26th June, 1959 and subsequently in drydock on the 7th July, 1959 for the purpose of ascertaining the nature and extent of damage stated due to heavy weather encountered whilst vessel lay at the anchorage in Colombo Roads on the 22nd June 1959.

The Master stated that whilst the vessel lay at the anchorage a high wind with accompanying heavy seas sprung up which caused the vessel to drag her anchors, the chain cables of which fouled the vessel's bottom plates. Soon afterwards water was stated to have been found leaking into the Nos.1 and 2 lower holds to a maximum depth of 6 feet.

Upon arrival in harbour the vessel was examined afloat but, attempts to locate the source of leakage "by the aid of a diver" failed. The vessel's Master stated that the engine room pumps

The vessel was placed in drydock on the 6th July, 1959, and upon examination, the following damage was found and repairs recommended without prejudice to the terms and conditions of insurance.

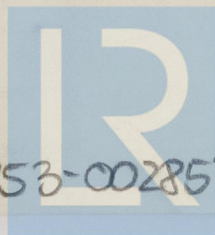

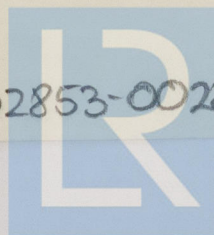
