In reply to your letter of the 30th April re First Entry Report of the steamer "D I N O G A" and the information which you desire in regard thereto. I beg to state that Mr A McCewan, Surveyor Melbourne witnessed the testing of the Anchors with one exception and this exception was the kedge anchor, which according to the Certificate was tested at Cradley Heath by Mr T C Perrel on the 26/3/15

The bulkhead stiffeners, Thickness of inner bottom plating, in boiler space, diameter of rivets in keel butts, rivetting in butts of side plating, bridge sheerstrake, upper deck stringer plate clear of the bridge, butts of inner bottom plating and the number of hawsers and warps are all as approved.

I herewith enclose report 11b on Freeboard this was omitted owing to the fact I had no forms but I think it was mentioned by me on the "DELUNGRA'S" that there was the three vessels of similar series, however I now have a supply of these forms on hand. I also enclose supplementary report 1 as desired of Longitudinal Framing trusting that this will meet your approval.
