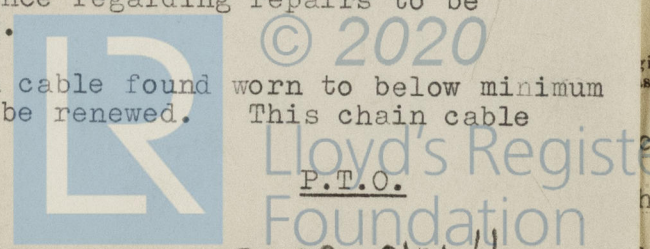

The thicknesses of shell plating as ascertained by drilling are as stated above and together with the repairs now effected have previously been approved.

The thicknesses of deck plating as ascertained by drilling together with the repairs now effected have previously been approved by London Office. In this connection refer Mr. Buchanan's memo of 6.7.56.
