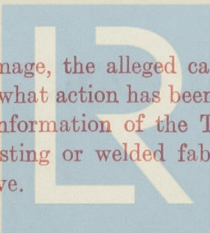

PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

S.R.L. Port Main Boiler main saturated steam stop valve to be renewed 1,65.

The Owners' Representative stated a new valve had been ordered but would not be delivered before the ship sailed. The welded repair to this valve now specially examined and considered to continue efficient. It is recommended that the port main boiler saturated steam stop valve be renewed by 5,65.

The reason for repairs must be stated and those on account of damage, the alleged cause of which must be given, should be detailed separately from wear and tear repairs. State what action has been taken regarding items which are subjects of class. State also where appropriate, for the information of the Technical Records Dept., the material of the defective item and whether it is a forging, casting or welded fabrication. Any alterations in existing particulars in the Register Book should be reported above.
