In reply to your letter dated 5th June, 1962 I have to inform you that the Surveyor now confirms that in connection with report No. 364 (Miami) the following alterations should be made:-

1. Diameter of Thrust shaft, 7"

2. Bilge Sections:-

Lower hold, 2-4 inch suctions to Fire Pump

Main Engine Room:-

5 - 2 $\frac{1}{2}$ " suctions to 2 - 4" ejectors

One 6" emergency to Ballast pump.

Auxiliary Engine Room:-

One 2" suction in each (P. & S.) led to E.R. ejector main.

A sketch is enclosed herewith showing the arrangement.

The modifications remaining to be made in the bilge arrangements consisted of a request that an additional 4" direct suction be fitted, however you may feel that in the circumstances this need not be insisted upon. I shall be glad of your views.

The note in the Surveyor's report regarding the similarity of the machinery arrangement to the M/V "ANGOCHE" was intended to relate only to the main engine and line shafting. As explained in our letter of March 21, it is suggested that the same power limits be imposed.
