I have surveyed the above-named ship in accordance with the Rules for Damage stated to have been caused by crew's mishandling of winch on the 3rd November 1965 at Chiba.

FOUND:

Main mast bent at mast bridge and on rigging broken and one turnbuckle of rigging broken.

DONE:

Main mast faired and fitted welded doubler in way of bent part.

All riggings and turnbuckles of main and foremast (total 12) now renewed.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with/without fresh record of dry docking, subject to any outstanding conditions of class being dealt with as previously recommended.
