We have surveyed the above-named ship in accordance with the Rules for wear and tear repairs to deep tank and tween deck plating.

DEEP TANK

Forward Bulkhead:

Fractured plating in way of bracketed stiffener to shell plating port side, at about 1/3 height, now repaired by electric welding and an efficient doubler fitted. On account of the confined space where the repair was effected, it was considered prudent that, to ensure water tightness, a cement box be fitted.

Aft Bulkhead:

Local wastage in the upper and 1st strakes below the tank top plating now dealt with by cropping out defective material and efficient insert plates fitted with welded connections.

Local wastage in the starboard upper corner of the tank fitted with an efficient doubler externally and a cement box, reinforced with steel framing, internally in order to ensure water tightness.

P.T.O.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. We recommend, therefore, that this ship remain as classed with/without fresh record of ~~dry docking~~ survey subject to "cement boxes fitted to fore and aft bulkheads of deep tank being specially examined and dealt with as necessary at next dry docking" and to any other conditions at present attached to the vessels class being dealt with as previously recommended.



On completion of repairs the deep tank satisfactorily withstood a head of water and was proven sound and tight.

TWEEN DECK PLATING

Local wastage of stringer plating adjacent to transverse bulkheads in fore and aft spaces and above deep tank at port and starboard side aft ends now dealt with by fitting five (5) doublers approximately 200 x 250 mm.

NOTE: This wastage of tween deck plating is considered to have been caused by water collecting in the corners and negligence of the ship's personal to dry up same and protect the plating.

This deck is the freeboard deck.

S.R.L. APPENDIX:

It is recommended that the item "doubler plates fitted to tween deck stringers and deep tank top plating, port and starboard" be inserted.
