I have surveyed the above ship in accordance with the Rules for equipment.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. Attended on board at request of Owner's Agents for loss overboard of port bower anchor along with one length of cable at Lat.08 degrees 27.5 N Long. 76 degrees 55.2 E, while shifting anchorage in Trivandrum Roads.

The pin of shackle joining 1st & 2nd lengths worked loose in shackle and sheared off hard wood locking pin and then slipped out of shackle disconnecting anchor along with one length of cable.

The port and starboard anchors were walked back and all joining shackle pins ~~xxx~~ examined. Four pins were found slack and these along with four lengths of cable were disconnected. No spare joining shackles on board.

Port anchor now has eight ¹²⁰lengths of cable and the spare anchor connected up. ²²⁵

Starboard anchor now has seven ¹²⁰lengths of cable.

I recommend that this ship remain as classed ~~with~~/without fresh record of dry docking but subject to one bower anchor and one length of anchor chain cable along with one joining shackle being placed on board by October, 1965 (six months) and to the defective pins of joining shackles of the four lengths disconnected at Trivandrum Roads, being specially examined and dealt with at Calcutta where vessel stated proceeding, but not later than the 6th May, 1965 (one month); and that all other conditions of class at present attached to the vessel's Classification ALSO FOR ^{2/2} being dealt with as previously recommended.
