GENERAL OBSERVATIONS, OPINION AND RECOMMENDATION AS TO CLASS

This ship so far as now surveyed is eligible in my opinion to remain as now classed with fresh record of DS 5.60 and to have the notation SS (Adv) 6.60 subject to side shell plating a.c. in way of No. 1 hold (ps) shell plates F 7; G 7 + 8 + 14; H 8, 9 + 14; J 8 (ps) F 12 + G 13; G 11, H 11; J 15 + 16 (ss) all from forward being dealt with as necessary at the next routine dry docking.
