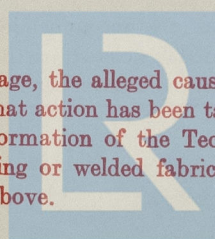

PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

State also where appropriate, for the information of the Technical Records Dept., the material of the defective item and whether it is a forging, casting or welded fabrication. Any alterations in existing particulars in the Register Book should also be reported above.
