We regret we have not replied to you earlier to your letter of the 30th ultimo, and we now refer to your yesterday's favour contents of which we noted.

Unfortunately, our Superintendent Engineers are abroad, but copy of your letter of the 30th ultimo was passed on to the Owner and we are awaiting for his instructions.

You are no doubt aware that the vessel run aground on leaving Salvador Bahia, on the 17th April and she is still at Salvador in damaged condition and she is expected to sail today for Rio de Janeiro for the purpose of drydocking and inspection of the bottom.

We have no doubt that the Owners have in mind the Special Survey and the items which are due, and we are full of hope that they will attend same when the vessel's bottom will be permanently repaired at Rio de Janeiro.
