From the above you will see that the vessel's Special Survey and Steampipe Surveys both are due in August, '66 and we accordingly intended completing these surveys on their due dates in Japan where she was expected to call in August, '66, but unfortunately she has been delayed at her loading ports in France wherefrom, after loading, she has now proceeded to Karachi. Thus she is behind her schedule by 2 months. Keeping in view her present schedule we requested the Lloyds Hongkong on 23-6-'66 to allow us to complete the balance of special survey together with steampipe survey in Japan in October, '66.

According to your latest telegram quoted above we see that your goodselves do not agree with our view and grant extension beyond August, '66. Since the vessel is expected to call at Karachi by 13th/14th August, '66, we request you to please permit the Lloyds Karachi to conduct a general examination of the vessel before she sails for Japan. If your goodselves do not agree to accede to our request especially in the cir-


