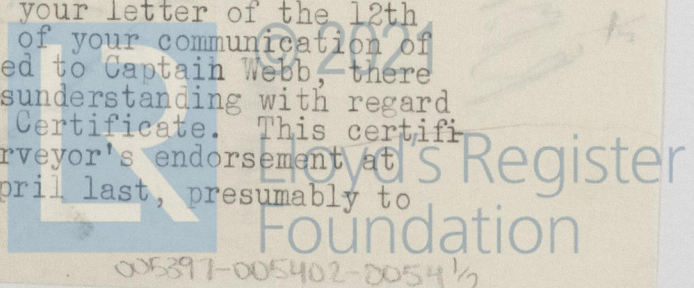
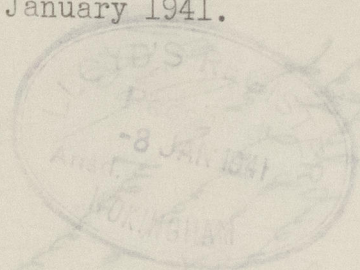

LOAD LINE CERTIFICATE
"ARMADALE"

With reference to the issue of a new Load Line Certificate for this vessel, which you advised us was necessary, we quote hereunder an extract from a letter from our Sydney Agents on this subject, which is self-explanatory:-

"As this vessel had left Sydney prior to receiving your letter of the 20th September, asking us to have the Load Line Certificate renewed, we arranged for the matter to be attended to in Adelaide, and we cannot do better than quote extract of their letter, which is self-explanatory:-

"With reference to your letter of the 12th inst., enclosing copy of your communication of the same date addressed to Captain Webb, there appears to be some misunderstanding with regard to vessel's Load Line Certificate. This certificate bears Lloyd's Surveyor's endorsement at Liverpool, dated in April last, presumably to

'cover 1939, and a further endorsement at
'Wellington during October provides for the
'current year, although we are of the opinion
'that the last mentioned Surveyor endorsed same
'unintentionally, being under the impression
'that a Seaworthiness Certificate was being
'granted following repair work which was carried
'out at that port.

'We discussed this matter fully with the
'local Lloyd's Surveyor, who has decided to
'despatch to Lloyd's London, both copies of the
'Liverpool Lloyd's Certificate, in lieu of which
'he has issued Provisional Certificates, which
'have been handed to Captain Webb'.
