Dear Sir:- S.S. "CRAGGAN HILL".

In reply to your letter of the 27th inst., concerning the verification of the Freeboard markings and a Periodical Freeboard Survey on this steamer we beg to inform you as follows:

The ship arrived yesterday at Terneuzen, Holland, to discharge her cargo, but we are afraid it will not be convenient for your Surveyors to carry out the requirements in question, on account of the discharging operations. The ship will, however, proceed to Sunderland for repairs and an outward cargo, after completion of discharge at Terneuzen, and we propose to have the said Freeboard requirements dealt with at the above mentioned port of Sunderland. We expect the "Craggan Hill" will sail from Terneuzen on Tuesday or Wednesday and she will touch at Flushing for bunkers on the way.

We regret the delay in this matter in general, but trust that the above arrangement will be found ^{as such} convenient for your Surveyors as it is ~~such~~ for ourselves.
