Dear Sir,

s.s. "LILLY MARGRETHE"

We have received your letter of 28th ult. and refer to our earlier letter of to-day.

We do not fail to inform you, that during the repairs at Haugesund precautions have been taken to eliminate the danger of fire caused by the donkey funnel going through the bunkers.

Owing to the construction of this ship, we found the best arrangement would be to lead the funnel the same way as earlier and build a scot across the bunkers, in sufficient distance from the funnel. A fireproof room has thus been made, with entrance through a manhole, and neither bunkers nor cargo should get in touch with the donkey funnel or fire arise out of heat from same.

We do not omit to mention that our Mr. Iversen jr., who was present at Haugesund when this alteration was made, mentioned the said alterations to your surveyor, but Mr. Eide never troubled to have a look at it.
