I have to thank you for your letter of the 16th instant in connection with the S.S. "IERE", and this will confirm cable sent you on 23rd instant, which reads as follows:-

The repairs recommended by me were all carried out in a satisfactory manner.

During a short trial trip in the Gulf of Paria the main engines and auxiliaries operated in a satisfactory manner.

I passed on to the Owner the information contained in your cable of 12th instant, and as it was impossible to have the ship dry docked at this port he decided to proceed to Martinique to obtain a Load Line Certificate from a Bureau Veritas Surveyor.

I am forwarding, under separate cover, a copy of report on this vessel, and will credit your office with the sum of 25/- in my next quarterly returns.
