s.s. "Aino Nurminen"

As you will find on reverting to our correspondence of last autumn concerning the above vessel, you were in agreement with us regarding the postponement until the end of 1950 of the special survey which had become due.

At the beginning of this year when we were making the necessary arrangements for the completion of the repairs in connection with the special survey, we were approached by a Finnish buyer, who was willing to take the vessel over later on in the spring, subject to certain repairs being carried out to the satisfaction of the Norwegian Veritas, in which classification society the buyer wished to enter the vessel in question, and some other conditions fulfilled. These conditions, however, have not been complied with by the date fixed at the time, and we, therefore, found ourselves obliged to cancel the sales contract which had been made.

As for the reasons mentioned above the vessel has not been classed to the requirements of your Classification Society, we much regret that we are obliged to draw your attention to the fact that our s.s. "Aino Nurminen" now belongs to the Norwegian Veritas Classification Society of which please make a note of in your Register.
