With reference to your letter of the 11th inst. I have to inform you that it has been ascertained that these vessels have been sold to "NAVEGAÇÃO E COMERCIO CARNEIRO MENDOZA, S.A. and have been renamed "JURANDY" and "CONSUELO" respectively: The owners address is AVENIDA RIO BRANCO, 9 - 2nd floor, Rio de Janeiro.

These new owners were contacted today and it transpires that the vessels were drydocked in June of this year. After docking the vessels went into service. The owners state that they have acquired the vessels under The Banco do Brasil, that it is their desire to have the vessels reclassed and that this matter will be taken up with the Bank and this office informed of the decision. It has been pointed out that to comply with reclassing requirements the vessels will have to be redocked and a complete reclassing survey carried out on each vessel.
