CLASSIFICATION S/S. "RIO VERDE"

The owners of the above vessel, Compañía Marítima de Punta Arenas, S.A., wish to know what procedure must be followed in order to obtain the reclassification of the "Rio Verde".-

I enclose herewith a copy of their letter to me dated today and shall be obliged if you will send me full particulars of Lloyds requirements in this connection.-

If you will refer to the correspondence between us of December 1945 and January 1946 you will notice that the vessel then lost her classification because the owners were not prepared to undertake the repairs recommended by the Surveyor appointed by me. The owners were then the Compañía Chilena de Navegación Interoceánica, who are now interested in the Compañía Marítima de Punta Arenas, S.A. to the extent of 50% of the paid up capital.

To assist you I enclose a copy of the Surveyors report mentioned in my letter of January 9th. 1946.-

The point has arisen because the present owners are making voyages between Punta Arenas and Valparaíso (even up to Callao) and have just been notified by local underwriters that they are unable to continue insuring the "Rio Verde" unless she is brought up to date as regards Lloyd's requirements. This position also affects the shippers of cargo who consequently become reluctant to ship on this steamer.
