I duly received your cable of the 5th. instant reading
as follows :-

"appreciate some indication extent of your surveyor's repair
"recommendations please cable principal details

and I now beg to enclose herewith a copy of my surveyor's recommendations in this case; I havenot cabled you because of the difficulty of explaining briefly the principal details of the report. I have no doubt you will find this satisfactory.-

I understand from conversations I have had at the owners office that there was a difference of about \$300,000.- Chil. between the estimated cost of the repairs as recommended by the Surveyor and those which the owners felt necessary to keep the vessel in running order for their own requirements.-

The Owners decided that in future they will carry their own insurance on these vessels, eg. "Rio Verde", "Santa Cruz", "Patagonia" ect. and that in consequence they were not prepared to go to the extra expense in the case of the Rio Verde to maintain the classification.-

I trust that the foregoing is all that you require but should there be anything else I am at your service if you will kindly let me know.-
