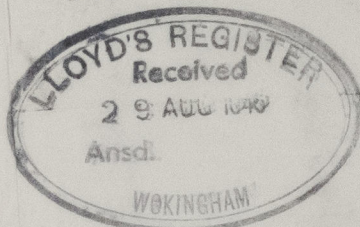

Dear Sirs,

S/S. RIO VERDE

The owners of this vessel, Compañia Chilena de Navegación Interoceánica, have informed me that they have recently received a communication from Mr. Wallace, Lloyd's Register Surveyor at Valparaíso, asking them whether they intend to apply for Special Survey No. 1 on this vessel. Apparently Mr. Wallace's note to the Compañia Interoceánica is in relation to some communication of your goodselves to him on the same matter.

There seems therefore to be some misunderstanding because in the first place Mr. Wallace really has nothing to do with the case of the S.S. "RIO VERDE" being stationed at this port as heretofore (previously all Lloyd's Register of Shipping communications have been addressed to the undersigned) where consequently any survey must be held and secondly the vessel already had her Special Survey No. 3 in May 1941 at this port as you will see from reference to my letter dated May 27th. 1941 enclosing Rpts. 8 & 9.

It would therefore appear that the steamer is now due for Second Special Survey No. 3 and as the owners intend placing her on the slips in September next for a general overhaul I shall be glad if you will let me have your instructions by cable as to whether I am to attend to the matter or not. If you cable me on receipt of this letter your reply should be here in good time; by letter the overhaul will probably be completed ere your reply comes to hand.

I have only to add that the owners wish to maintain the S.S. "Rio Verde's" classification and to hold the corresponding survey.
