Dear Sir,

In reply to your letter of 9th April relating Kobe First Entry Rpt.No.2729 on the steamer "SHINTO MARU" at that at the docking survey held the 22nd February last it overlooked that the requirements of the Committee's cablegram of 9th April not yet carried out. The telegram and letter of subsequent date to the completion of the survey during action and their contents had been duly communicated to the officers on 14th April 1919. The Builders state that these requirements shall be carried out on the occasion of the vessel's docking in May next.

A sketch of the stepping of the mast on the shaft tunnel is enclosed. The poop deck extends to frame No.8, length 16 feet, but is not complete, there being an open way all round the house and large openings on the poop side plating.
