REPAIRS, OR EXAMINATION AS PER RULE, FOR CONDITION & DAMAGE-

NOW DONE:- Vessel placed in dry dock, bottom and rudder examined and after repairs as under found good and recoated. Rudder post where electrically welded found satisfactory Decks, hatches, ventilators, coamings and equipment generally examined and found satisfactory. Freeboard verified.

DAMAGE- Stated due to grounding in Canal while approaching the port of Alexandria on 3rd July 1926,

DAMAGE REPAIRS NOW EFFECTED:- Port side under boiler room one shell plate in B strake removed, faired and replaced. Six frames in way and 3 floors in way faired in place.
