Re: Extension of Annual Survey
for S.S. "EMPIRE MERCHANT".

We have received some strong requests from the present Charterers of the ship to defer the Annual Survey, due July 1956, until late September or October of this year.

Messrs. P. C. Ray, the Charterers, employ this ship to lift timber from the Andamans to India, and they said they are falling back in their delivery programme, and wish to have the Survey postponed until expiration of charter, which is in February, 1956, or at least to the above date.

We are definitely not inclined to postpone this Survey very long. But, to assist a client, our Company are quite agreeable to have it postponed until October provided permission is obtainable from you beforehand.


