The remarks of the Chief Ship Surveyor are desired on this case for the consideration of the Classing Committee.

("The endorsement to contain a succinct summary of any repairs that have been required and to show the cause or causes of such repairs, and also to bring out clearly any exceptional features in connection with the case, so that the Classing Committee may have all the salient points presented in the endorsement."—Extract from Sub-Committee's Report, 24/5/52.)

The class is subject to bottom shell plating being specially examined by 12,54, and to permanent repairs to set over stem and stem plating, etc. and to set up bottom shellplate B.4 (p.s.) at the Special Survey.

There is an Endorsement of Class (B).

The ROTTERDAM Surveyors report 7,55 this ship placed in drydock and due to damage from various causes, particulars of which could not be obtained, permanent repairs effected to shell plating, etc. (p & s) also to the rudder and to the Endorsement and Conditions of class.

The requirements of a Special Survey (C) due 9,54 have been complied with and repairs effected to deck plating, etc., the length of the ship has been increased by approximately 29'-2" by the insertion of a new portion between cargo holds Nos. 1 & 2.

Concurrently with the above the upper deck has been raised to the same level as the former R.Q. Dk.

All alterations have been effected in accordance with approved plans.

The above alteration has increased the Equipment Numeral and to compensate for a deficiency in the tubular weight of the anchors and ~~chain cable~~ chain cable, an additional 60 fathoms of chain cable have been placed on board and verified with certificates.

IT IS SUBMITTED the ship is eligible to have record of docking 6,55 and notation of "ss. Rot. 7,55" assigned as recommended, without special condition.
