We beg to refer to the ^{survey} ~~service~~ certificates issued by you in respect of the above vessel on the 13th July 1959, 24th June 1960 and 12th August 1961, all of which referred to bottom damage which consisted of indented shell plates A-1 and B-1, s/s f'rd. which were to be specially examined and dealt with as necessary at next dry docking. It is our practice normally to dry-dock the vessel for annual survey in the course of the summer months but as we are now contemplating selling the vessel it will be necessary to dry-dock her very shortly in order that buyers may examine her under water parts.

Could you therefore please look into the matter and confirm that when the last record of docking was made in August 1961, it was intended that the conditions referred to above were not to be examined until the vessel was next dry-docked for her annual dry-docking and that the damage itself would not therefore have to be specially examined should she be dry-docked later this month.
