

and that I will transmit to the Committee of Lloyd's Register of Shipping, London, a Report stating that all recommendations made by me in connection therewith have been carried out to my satisfaction; also that I will Recommend that in the case of this Vessel the following Survey Records be made in the Supplement to the Register Book B.S. (with suitable date) and M.B.S. 10.59 when the Surveys have been completed,


and that her Machinery Classification Record be continued in the Book, subject to any outstanding conditions of class being dealt with as previously recommended.

Parts now examined:

To complete the B.S.:- Inboard & outboard feed pump buckets to be renewed. All rule requirements to be complied with except:- Inboard & outboard generator engines. Fan engine condenser circulating pump and engine. Inboard and outboard feed pumps.

To Complete for record of M.B.S. 10.59 All main boilers to be examined under steam, their safety valves adjusted, and oil burning system and remote controls examined under working conditions.
