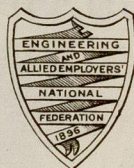

CONDITIONS OF SALE.

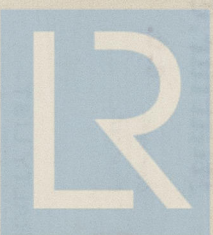
In computing the time within which anything is to be done by or any default is to be considered as arising or continuing by this Company, there shall be wholly excluded the period of any delay arising in any way at any time between the date of acceptance of this quotation and the actual completion and delivery of the article or articles or the carrying out of any work the subject of this quotation, from the consequences of war, Government control, or requirements, lock-outs, strikes, cessation or restriction of work, or combination of workmen, whether of this Company's workmen or of the workmen of any person, firm or company causing any stoppage, restriction or delay in the supply of materials to this Company or otherwise impeding, interfering with, or delaying them in the progress and completion of the work, or from defective castings, forgings, or other defective material, whether supplied by this Company or their sub-contractors, or from accidents, or from the state of the wind or weather, or from transport delays, or from any cause of any kind whatsoever not absolutely within the control of this Company existing at or arising after the date of this quotation whether the manufacture of the article or articles offered or the work to be performed shall have begun or not.

No penalties or damages shall be payable by this Company for any period of any delay occasioned as aforesaid or in respect of any allowance damages or costs which shall be paid by the Purchasers to any person or persons in connection with the sale or delivery of the said article or articles or the performance of any work.

Every reasonable care shall be taken to produce reliable materials and good workmanship throughout, and if any defect in the material or workmanship be discovered during manufacture or within six months of despatch from this Company's or any sub-contractors' works, and unconnected with wear and tear or inefficiency or carelessness of purchasers or their agents, such articles in which the defects are discovered will be replaced, or the defects remedied by this Company at their own works or at a cost equivalent thereto, but their liability does not extend to any loss of damage whatsoever direct or indirect caused by the failure of such defective article or from injured workmanship or for any delay occasioned thereby, but only to the cost of the actual replacement or remedy of the article or work, and on and after the expiry of such six months all liability upon, and all liability of this Company whatsoever, whether in respect of any breach of any of these conditions or of any failure to remedy defects, shall be absolutely irrevocable and a release, nor shall this Company's liability ever or in any case and either before, during or subsequent to the expiration of the said period of six months extend to any indirect or consequential damage of any kind whatsoever.
