Although the A.B.S. report is dated 12th March, it was not sent to us until 22nd March and we received it the following day.

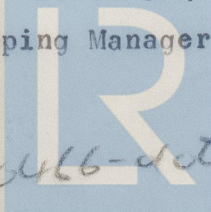
