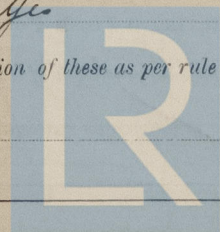

Cables: Single, twin, concentric, or multicore Single are the cables insulated and protected as per Tables IV or V of the Rules Yes.

Fall of Pressure, state maximum between bus bars and any point of the installation under maximum load 3.5 volts.

Cable Sockets and other connections, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets Yes.

Paper Insulated Cables. If cables are paper covered, is the dielectric at the exposed ends of the conductor protected from moisture by being suitably sealed with insulating compound —.

Cable Runs, are the cables fixed as far as possible in accessible positions not exposed to drip or accumulation of water or oil, or to high temperature from boilers, steam pipes, uptakes or other hot objects, or to avoidable risk of mechanical damage Yes.

Support and Protection of Cables, state how the cables are supported and protected Lead covered & armoured in machinery
glass & through holds clipped up with galvanised iron clips. Lead covered supported with brass clips in accommodation
 If cables are run in wood casings, are the casings and caps secured by screws —, are the cap screws of brass —, are the cables run in separate grooves —. If armoured and lead covered cables are secured by metal clips, are the clips spaced as per Table VIII Yes.

are any fittings placed in spaces where inflammable or explosive dust or gases are liable to be present, if so, how are they protected —.

Flood Light Searchlight Lamps, No. of 1, whether fixed or portable Portable, are their fittings as per Rule Yes.

are they protected from mechanical injury and damage from water, steam or oil — are their axes of rotation fore and aft —, if situated near unprotected woodwork or other combustible material, are the motors of the totally enclosed, pipe ventilated, forced draught, drip or flame proof type —, if not of this type, state distance of the combustible material horizontally or vertically above the motors — and —.

Control Gear and Resistances, are the generator field and motor speed regulators, starters and controllers constructed and fitted as per Rule Yes.

Lightning Conductors, where lightning conductors are required, are these fitted as per Rule Yes.

Ships carrying Oil having a Flash Point less than 150° F. Have the special requirements of the Rules been complied with regarding switches, joint boxes, section and distribution boards, protection of cables, method of distribution, lead of cables, lights and fittings —.

If portable lamps for use in dangerous spaces are supplied, are they of a type approved by the Home Office —.

Distance between electric generators or motors and steering compass 57 ft.

The nearest cables to the compasses are as follows:—

A cable carrying 1 Ampères in feet from standard compass 8 feet from steering compass.

A cable carrying 1 Ampères 8 feet from standard compass in feet from steering compass.

A cable carrying 9 Ampères 10 feet from standard compass 6 feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power Yes.

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted Yes.

The maximum deviation due to electric currents was found to be nil degrees on any course in the case of the standard compass, and nil degrees on any course in the case of the steering compass.
