

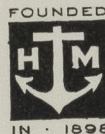

The above vessel is due for Special Survey during the present month, and we should like to submit this vessel to a General Examination for extension of the Special Survey. As this ship has been trading in the Black Sea area, we have not been able to put forward a proposal for General Examination at an earlier date. At the present moment the ship is on passage to Sihanoukville, Cambodia, and on completion of discharge will proceed to either Japan or Hong Kong.

We expect the ship to be in either of the latter places in early December, and would be glad to have your approval for carrying out the General Examination at either of these places. We will advise you of exact destination at the earliest possible time, so that the necessary arrangements for this examination to be carried out can be made.
