Dear Sir,

Steamer "ANTHIPPI MICHALOS".

We have received your letter dated the 14th November, and in view of what you write, we do not propose to pass it to the Owners in its present form because we feel the facts are incorrectly stated.

We must make it quite clear that the Society's Class was not relinquished because of the recommendations made by your Surveyors. It was because the other 5 ships of these Owners/Managers are with the American Bureau of Shipping, and for no other reason.

The allegations made by you are most emphatically denied, and you are requested to withdraw them.

For your information, we would like to mention that the vessel is still in London undergoing conversion, and by the time the repairs and recommendations are completed in Greece, everything will have been dealt with. As a matter of fact, additional recommendations were made by the American Bureau Surveyors, one of which was for "strapping", and we hope this will convince you that the Classification has not been changed to minimise expense.

When all the work is finished we will, if you wish, send you a copy of the American Bureau Survey Report showing recommendations and repairs effected.


