I have surveyed the above ship in accordance with the Rules for DAMAGE stated due to contact with Quay Wall at Berth Nos.38/39, Singapore on the 26th June 1963 whilst berthing alongside.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

DAMAGE (as above).Found:-

1. Soft nose stem plate and adjacent shell plates K21 (p & s from aft) set in and buckled. Rivets in stem plate connection to shell plate K21 (p & s from aft) started and leaking.
2. Three stud links of first length of starboard side chain cable scrubbed (contact with Quay Wall).

NOW DONE:- (Temporary Repairs)

1. All started rivets (approx. 30) in connection of stem plating and shell plates K21 (p & s from aft) electrically welded and made tight.

I recommend that this ship remain as classed ~~xxx~~ without fresh record of dry docking, subject to set in stem and shell plates K21 (p & s from aft) being examined and dealt with as found necessary at the next drydocking and to compliance with all outstanding recommendations previously made by the Society's Surveyors.

NOW DONE:- (Temporary Repairs) Cont.

1. All started rivets (approx. 30) in connection of stem plating and shell plates K21 (p & s from aft) electrically welded and made tight.
2. Shell plate caulking in way of started rivets now welded and made tight.
3. Stud links of starboard cable (1st length) examined, callipered and found to continue efficient (mean diameter at damaged part 2 7/16").

It was finally recommended set in stem plate and shell plates K21 (p & s from aft) be examined and dealt with as found necessary at the next drydocking be considered efficient meantime.
