



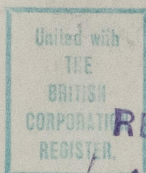

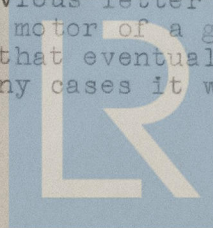

Further to my letter dated Nov. 1st in reply to the classing letter dated July 12th requesting certificates covering electric generators and motors, I append hereto, in duplicate, revised sheets which should replace the sheets attached to Test Reports 98098, 98099, 98100, 98101, 98102, 98103 and 98123 forwarded with my previous letter, as it appears that motors shipped for Hulls 566 and 568 were installed on Hulls 567 and 569, and vice versa.

I am also forwarding herewith, in duplicate, Test Reports covering the motors for the services indicated below:-
