EXAMINATION AND REPAIRS AS PER RULE FOR anchors & cables

Port and stbd. bower anchors and cables ranged and examined.

It was noted that the shank of the starbd. bower anchor was slightly bent.

The Owners' Representative requested that the repair of this anchor be deferred until the next Special Survey (due 4.63) and since, in my opinion, the efficiency of the anchor is not impaired, it is submitted that this request could be given the favourable consideration of the Committee.

A Co2 fire extinguishing installation, additional to the existing approved fire fighting arrangements on board, has been fitted to all holds, tanks and store spaces. The CO2 bottle room, strongly constructed of steel has been fitted on the Boat Deck, port side outboard of and separate from the main machinery casing, with separate access door from outside, and adequately ventilated.

A copy of the general arrangement plans Nos. SE 4783/1A, 2A & 4A are attached herewith for your information. (NOT WITH CASE)
