Steamer "EMPIRE VICEROY"

As you are aware, the above vessel has now been sold with a view to conversion to an ore carrier.

At the request of Messrs. Cornes & Co. the Salvage Association Report covering the survey carried out by us during August 1952 and subsequently has now been completed. This report has been withheld until now as no instructions were received from the Owners in regard to the necessary repairs.

We shall be obliged if you will kindly render an account to the Salvage Association for £150 covering 40 visits paid to the ship by the Surveyors in the course of the survey and sea trials.

We think it well to add that the Salvage Association, London, are fully aware of the fact that a Final Report has not previously been submitted as this point was mentioned by both Mr. Sedgwick and Mr. H. Warkman during their visits to this country on behalf of that Association. Messrs. Cornes & Co., Kobe, also advised London of the fact in their letter dated 23rd June last.

One copy of our Report L.A.19911 is attached hereto for your information.

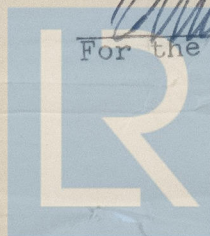
