EXAMINATION AND REPAIRS AS PER RULE FOR DAMAGE:

Damage stated to have been caused by fire in part of the cargo of coal being carried in No.2 hold adjacent to centre line bulkhead between Nos. 2 and 3 hatches between the 9th and 17th April, 1962 during the voyage Calcutta-Colombo-Bombay.

Now found : Damage confined to fore end of centre line bulkhead in No.2 hold between Nos. 2 and 3 hatches.

Base plate and first two vertical strakes of plating from fore end buckled.

Double B.A. stiffeners at fore end of bulkhead buckled.

Second B.A. stiffener from fore end buckled.

Starboard bottom bracket on double B.A. stiffeners buckled.

Small area of tank top ceiling adjacent to bulkhead charred.

The Owner's Representative requested that repairs be deferred until next drydocking and in my opinion this is a reasonable request and merits the favourable consideration of the Committee. The structure is considered to continue efficient meantime.
