Damage stated to have been caused when coming in contact with Hopper Barge No.26 off Dunglass in the River Clyde 4th September, 1964.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

NOW DONE:-

Port Side Forecastle bulwark plate (11'-0") cropped & part renewed.  
Bulwark top rail bulb angle in way cropped & part renewed.  
2 bulwark bulb plate stays in way renewed.

Port Side Shell Plating Indented shell plating 'B' strake (bilge) and strake above in way of 7th frame forward of E.R. bulkhead faired in place.  
Rubbing strip (cope bar) at top of bilge strake cropped & part renewed.

Main Framing port side 7th frame forward of E.R. bulkhead cropped & part renewed.

Repairs carried out to shell plating hose tested on completion.
