I have surveyed the above ship in accordance with the Rules for Docking and Damage Repairs.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

DAMAGE:- Stated caused by explosion in the port O.F. deep tank whilst at Escombreras discharging cargo on 3rd. November 1965. The cause of the explosion was unknown, but it was stated that a member of the crew was working on the sounding pipe cap of this tank in the tween deck.

FOUND:- PORT O.F. DEEP TANK

For'd bhd. (95) badly bulged and split, torn at connections to shell deck and tank top. Shell plating and deck plating in way bulged. Longitudinal bulkhead badly distorted and bulkhead of daily tank distorted. Tank top in way of for'd bhd. fractured.

I recommend that this ship remain as classed with/without fresh record of dry docking 1,66 without subject regarding repairs to port O.F. deep tank but subject to any other conditions at present attached to the class being dealt with as previously recommended.

#### BULKHEAD 95

Renewed complete with stiffeners and stringers from ship side to about 1 M. inboard of longitudinal bulkhead.

LONGITUDINAL BULKHEAD renewed complete.

BULKHEAD 88 (between daily tank and deep tank)

Stiffeners renewed, bulkhead plating faired in place, stringer part renewed.

#### TANK TOP

Outboard strake one plate part renewed frs. 93 to 97.  
1st. strake inboard one plate part renewed frs. 94 to 96.  
Centre O.F. tank, port O.F. tank and daily tank satisfactorily pressure tested on completion.

596 Propeller and outside fastenings examined and found satisfactory, wear down 2.0 mm.

CONDITIONS OF CLASS (S.R.L. No 246) NIL

(Condition of Class regarding anchors, Gijon Rpt. No 429)

The Owners' Representative stated that one anchor was being tested in Bilbao and that this would be put on board at the next visit there; the other anchor would then be removed and tested.

It is recommended that the condition regarding repairs to Port O.F. deep tank (Valencia Rpt. No 2049) be now deleted.
